



Mock Oral Board Examination Preparation Course

The University of Colorado Department of Ophthalmology is again offering the only full-length, mock oral examination for ophthalmology in the country. This half-day course is designed to replicate the actual oral exam in every aspect possible.

The purpose of the course is to improve examinees readiness for the oral board examination through a live oral exam that closely simulates the format, content, and timing of the actual examination. In simulated exam rooms, attendees will complete six 30 minute, face-to-face encounters with examiners who present up to ten clinical cases and describe how they would care for that patient. Upon completion of the mock exam, attendees will have the opportunity to review their performance with examiners and receive feedback on ways to improve exam techniques.
