SSA2: Town Hall Meeting on Violence

Trauma can throw individual lives into chaos and fill survivors with the experience of loss, injury and death, as well as a terror of repeated trauma. When traumas and disasters occur on a larger scale, these emotions are amplified across communities, and the costs and societal burden can be tremendous. As general internists, we are at the front line of dealing with the reverberations from these events through caring for trauma survivors, and affected family and community members.

This Town Hall meeting will provide a forum for SGIM members to voice their stories regarding the impact of a severe trauma such as the Arizona shootings on their practice and their community. How can we help the survivors, affected family and community members? What can we do to prevent these events from happening again? We have assembled a panel of experts in mental health, primary care, advocacy, and law to lead the Town Hall discussion.

Charles Arnold, JD (Chairman of the Maricopa County Superior County Task Force on Mental Health Services and past Vice President and Board Member of the Mental Health Association of Maricopa County) is an expert on the intersection between mental illness and the legal system who will address physician responsibilities to notify law enforcement of potential perpetrators of violence.
