- ❖ Tuition and fee bills are online only. Students access bills through [ucdenver.edu/UCDAccess](https://ucdenver.edu/UCDAccess).
- ❖ Nonrefundable 2.75% service fee applies to all debit/credit card payments. No fee for online payments from checking or savings accounts.
- ❖ Excess financial aid funds refunded via direct deposit into your bank account, or a paper check mailed to your postal address listed in the UCD Access Portal. Remaining Parent PLUS loan funds may be refunded to you or to the parent depending on what your parent selected on the loan application.
- ❖ Direct deposit refunds may take approximately 3 to 5 business days from the time a credit balance is created on the student's account. Paper check refunds process weekly on Tuesday and Thursdays, mailed to the mailing address in the UCD Access Portal.
- ❖ Payment Plan auto-debit/auto-withdrawal will occur on the next business day if the 20th of the month falls on a weekend or holiday.
- ❖ Dates listed above are subject to change.
