Request for Immigration Document: F-2 or J-2 Dependent(s)

Procedures: Please complete the following form to request that ISSS create an I-20 or DS-2019 for your dependents. After we receive all required documents and information, ISSS will process your request **within 10 business days**. When your documents are ready, you will receive an email to your university email address. I-20s will be sent by email. DS-2019s must be picked up from ISSS or sent by mail. In addition to providing the information below, you will also need to provide financial documents to show how you will cover the living expenses for your dependents. If you need space for additional dependents, please use another copy of this form. Please number each dependent and provide the total number of dependents to be added to your SEVIS record.

Estimated Living Expenses for Dependents

All CU Anschutz students must provide financial proof that they can provide for their dependent's living expenses for at least one year or the duration of their program if their program is less than a year. Students need to show at least **\$750 per month** for each dependent. For most degree students, your financial proof needs to show at least **\$9,000 per dependent**. Please remember that your financial documents cannot be more than **six months old**. If a family member or friend will cover your dependents' living expenses, they will need to complete a [Financial Commitment Form](#).

Sponsored students who are using their sponsorship funds to cover your dependents' living expenses must have a financial guarantee letter for the upcoming academic year in order for ISSS to create documents for your dependents. If you cannot receive the updated letter in time for your dependents to apply for F-2 or J-2 status, you will need to provide personal financial documents as described above.
