[2] Independent instruction: dissertation, field studies, independent study, internship, practicum, research, or thesis. Students in pipeline courses only, including high school concurrent students, are in this fee group. Students may elect to pay all fees, but may not select individual fees.

[3] All extended studies courses will be assessed the Information Technology and Student Information System fee (SIS Fee) based per Extended Studies credit hour of enrollment.

[4] Fee minimum is 3 credit hours per term (\$37.02) and fee maximum is 15 credits (\$185.10).

[5] Candidate for Degree and Non Credit students pay Non Credit Only fees.

[6] OIA/ESL students pay full, on-campus fees, including the Information Technology and Student Information System fee (SIS).

[7] Students may be subject to instructional program, and course fees based on enrollment and major. Please see the Student Finance web page for these fees.

Additional Notes:

XMBA, XMHA, GEMM/Risk Management promote a fixed cost of the program. XMBA and XMHA students are billed a flat rate. GEMM/Risk Management students are billed a flat rate. Programs operating on both Denver and Anschutz campuses will either be charged by a term active program-plan associated with a campus OR will arrange a revenue transfer by memorandum of understanding.

Any graduate student who is not registered during the term but taking comprehensive examinations must register in a "candidate for degree" plan and pay one credit hour of resident tuition plus Non Credit Only fees.
