[2] Includes all CU buildings (as of FY 13-14 this includes Lawrence Street Center, CU Denver/Dravo, 1475 Lawrence/Business School Building, and CU Denver buildings on the Auraria Campus). On campus includes any course with an in-person instructional component occurring at these locations, including hybrid courses.

[3] Independent instruction: dissertation, field studies, independent study, internship, practicum, research, or thesis. Students who are enrolled in in-person classes at South Denver only, including high school concurrent students, are in this fee group. Students may elect to pay all fees, but may not select individual fees.

[4] ESL students pay on-campus fees.

[5] Fee minimum is 3 credit hours per term (\$36) and fee maximum is 15 credits (\$180).

[6] Students may be subject to instructional program, and course fees based on enrollment and major. Please see the Bursar's web page for these fees.

**Additional Notes:**

XMBA, XMHA, GEMM promote a fixed cost of the program. XMBA and XMHA students are billed a flat rate. GEMM students are billed a flat rate, plus the Info Tech and SIS fees, which add up to the promoted fixed cost.

Programs operating on both Denver and Anschutz campuses will either be charged by a term active program-plan associated with a campus OR will arrange a revenue transfer by memorandum of understanding.

Any graduate student who is not registered during the term but taking comprehensive examinations must register in a "candidate for degree" plan and pay one credit hour of resident tuition plus the SIS fee and the Info Tech fee.

Mandatory health insurance plan for all international students in the non-immigrant visa categories of F-1 and J-1 as well as students in Optional Practical Training (OPT).
