A. INTRODUCTION

1. Purpose

The purpose of this policy is to set forth guidelines for payment of parking fees for CU Denver | CU Anschutz faculty, staff, students, patients, visitors, volunteers, and contractors.

2. Responsibility

It is the responsibility of administrative personnel, Parking and Transportation Services Division, and individual faculty, staff, and students to ensure compliance with this policy. It is also the responsibility of the Parking and Transportation

Services Division to establish procedures for parking on both campuses and to ensure compliance with those procedures and fiscal policies.

B. APPLICABILITY

This policy applies to all users of parking facilities owned or leased by CU Denver | CU Anschutz and to the expenditure of any funds administered through CU Denver or CU Anschutz for such parking facilities.

C. DEFINITIONS

1. Employee is defined as an individual (full-time, part-time, temporary, seasonal, and hourly) who is employed by the University of Colorado per Internal Revenue Services definitions.
2. Student includes any individual who is registered or enrolled in a class or course offering of CU Denver or CU Anschutz.
3. Visitor is defined as an individual visiting the campus on a temporary basis and not being paid by any entity associated with CU Denver or CU Anschutz.
4. Patient is defined as an individual receiving medical services or participating in medical research through University of Colorado Anschutz Campus.
5. Volunteer is defined as an individual who volunteers without remuneration to assist, teach, or practice at CU Denver or CU Anschutz. They cannot be paid partially or completely by CU Denver or CU Anschutz to acquire the status of volunteer.
6. Contractor is defined as a construction company employee, contract laborer, or consultant working on a project and being paid by CU Denver or CU Anschutz.
7. Parking Fee refers to the amount assessed, on a regular basis and at a published rate, by CU Denver | CU Anschutz Parking and Transportation Services Division or an external parking provider for parking an employee's personal vehicle on CU Denver | CU Anschutz owned or leased parking facilities.
8. Parking and Transportation Services Division is the CU Denver | CU Anschutz auxiliary that operates as a self-funded enterprise.
9. Primary Place of Work or Study is the location where an employee is regularly and predominately assigned to work, or where a student primarily attends classes. Generally, if an individual spends half or more of their work time at a particular location or has their main office or work site at a particular location, that location is considered the employee's primary place of work used to determine the permit parking location.
10. Parking Permit is defined as an authorized parking permit or entry device issued by

the CU Denver | CU Anschutz Parking and Transportation Services Division. Also honored are permits issued by other University of Colorado campuses and Auraria Higher Education Center in accordance with reciprocal parking agreements.

D. POLICY

1. General

CU Denver | CU Anschutz units may not pay parking fees, as defined in this policy, for CU Denver | CU Anschutz faculty, staff, or students to park their vehicle at the employee's or students primary place of work or study. This is considered a personal expense of CU Denver | CU Anschutz employee or student and is not a reimbursable expense from any funds administered by either CU Denver or CU Anschutz.

All other individuals visiting the campus, whether they are patients, contractors, volunteers, or visitors, will normally pay for their parking services. Departments may choose to pay for parking for their patients, contractors, volunteers, or visitors.

Any faculty, staff or students parking a vehicle on the CU Anschutz Medical Campus will be required to participate in the parking program.

2. Payment for Parking Fees

The Parking and Transportation Services Division will not accept payments for parking from CU Denver | CU Anschutz departments except as outlined above. The Procurement Services Center will not process employee reimbursements or payments to vendors for parking fees at CU Denver | CU Anschutz except as outlined above.

3. Enforcement

The Parking and Transportation Services Division will ensure compliance with the fiscal policies and procedures established to provide parking for the CU Denver | CU Anschutz community.
